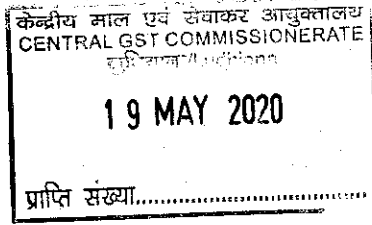

Sub: -Information Sought u/s 6(1) of RTI Act, 2005 - regarding:

The CHA, [Redacted] has stated 26.8.2013 as "up till now it is a fraud committed by my employees([Redacted] those prepared FAKE TR-6 challans) with me and I have already taken legal as well as police action against them. As far as amount embezzled by them, I have already deposit the same keeping in view my responsibility as a CHA. Also undertake to deposit the complete amount along with the panel interest as and when confirmed by the Bank/deptt." Copy annexed.

1. When the CHA has admitted to deposit the entire money along with interest and penalty, provide me information in simple form of the total embezzled amount, interest and penalty and is still pending to recover from the CHA firm.
2. The custom inspector, [Redacted] had snatched the Passport of my son [Redacted] during investigation violating customs' rules, which is in his custody; please inform me when you will return the passport in the interest of Justice. I have already informed you in this regard and ready to submit an affidavit by my son.
3. Provide me the cctv footage of investigation from my son, because he was simply a whistle blower which is clear as under:

As per Order no. 09/CUS/ASR/2014 dt. 03.06.2014 along with letter C No.VIII-48(19)Tech/RTI/Raghav/Cus/Asr/2014/10519 dt. 10.09.2014, copy annexed, It is stated on page no. 16 para (iii) that **Pawan Kumar, illegally appointed as custom officer** for illegal activities at Rail Cargo, conspired with Varun Mahajan, CHA's employee to forge the TR-6 challans and said that he will not enter the details of fake/ forged challans in the list sent to Bank for verification of the challans. Para (iv), he sits in main office at the 1st floor with the officers of the customs department, Rail Cargo Amritsar. Most of the official correspondence was also dealt by Pawan Kumar. **Para (v), Rs 80000/ (each challan) was being given to [Redacted] by CHA's employees,** copy annexed. Thus the ill-gotten amount has been shared actively among the defaulting staff and CHA firm who were beneficiary of entire embezzled amount of duty, which results willfully disobeyed the Govt. of India rules i.e. customs rules that are mandatory vide **circular F No. 224/37/2005-CX6 dt. 24.12.2008 and no imported goods detained.**

4. Tell me the period that custom inspector, [Redacted] had been posted at LCS, Rail Cargo, Amritsar and he will be fully responsible for any misuse of the passport because my son has never used the passport till date.

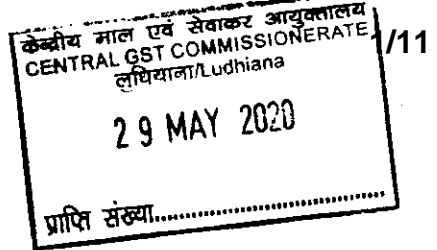
