The Commissioners from whose charge such officers are transferred out shall immediately provide such information in respect of officers in the above categories to the Commissioners under whose charge the officer is under orders of posting.
- c). Representations, if any against the above orders may be submitted by 10.06.2014.
- d). All the officers should be relieved by 20.06.2014 and the compliance reports, after ensuring handing over/taking over in terms of CCU letter C. No.175/Zone-14/Admn/Misc/2011/1905-09 dated 22.03.2012, may be sent to this office by the concerned Commissioners by 23.06.2014 positively.
