

- 3) The specific posting of the officers within individual Divisions will be done by concerned Divisional Deputy/Assistant Commissioner strictly with the concurrence of Addl./Joint Commissioner in charge. While posting the officers, they will ensure that the officers are rotated between sensitive and non-sensitive charges in accordance with transfer guidelines after verification from the HOP of the individual officer, which can be
