- (2) No TTA/Joining Time is admissible to the officers appearing at S. No. 28 and 31 above since their transfers are being ordered on their own request.
- (3) The specific posting of the officers within individual Divisions will be done by the concerned Divisional Deputy/Assistant Commissioners strictly with the concurrence of Additional Commissioner in-charge. While posting the officers, they will ensure that the officers are rotated between sensitive and non-sensitive charges in accordance with transfer guidelines after verification from the HOP of the individual officer, which can be obtained from AO (Et.I) Hqrs Office. The further specific posting of those officers who have been transferred to/retained in Hqrs shall be done by the ADC in charge, with due approval from Commissioner. The Deputy/Assistant Commissioners are also to ensure that officers under cloud or who have come to adverse notice of the department may not be posted to sensitive charge.
