NACIN Bengaluru has taken an initiative "**Ask Me**" which has now become operational at askme-nacinbangalore@gov.in. This initiative is the first of its kind at NACIN and extended to all ranks of Departmental Officers who have got any short term/long term/day training at NACIN, Bengaluru, from June 2017 onwards including 68th & 69th batch of IRS Probationers. This will be an ongoing process from now on.

2. "**Ask Me**" initiative is developed, with an objective to develop the knowledge, skill and behavior, which are required in an Officer, for effectively performing the functions of the current & future jobs. It enables officers who have been trained here, at NACIN, Bengaluru, to seek clarification on the trained topics, from the faculty, on specific uncertainties confronted by him/her, during the performance of official duties or as a part of continuous learning.

3. It is often felt that after the training programme, the officers going back to the field with several questions in their minds at different phases of time and work. Quite often they are not able to find answers to their doubts or wanting some additional information with respect to training imparted at NACIN. To bridge this gap, we have taken an initiative to create an email ID and circulate to all the formations in Karnataka and all over the country so that, the trainees can send their queries on this email. NACIN, Bengaluru will get back to

them with the answers, after interacting with the resource persons, who imparted these trainings. The replies will however carry disclaimer that the response, are the views of the resource person.

4. In view of the above, it is felt that all the formations, under the jurisdiction of the respective Commissionerates, may be advised to give wide publicity to "Ask Me" initiative, among the officers who have attended any course at NACIN Bangalore and anyone who in future will attend the courses. In effect, all officers of your jurisdiction should be aware of this initiative to help them "continuously learn". This is not one time effort but a continuous exercise.
